Tolentino said it made him feel really good.



"I got to see both sides of a lot of issues. I was a defense attorney as well." Alberto Tolentino said. "I think at this particular stage in my life, being able to do the duties of a magistrate is helpful to the community."

Those duties will include presiding over preliminary hearings for arraignments, bail hearings, and initial appearances, as well traffic court, small claims, and even some civil cases.

Although his mother was not in the audience because she is not on island, Alberto Tolentino said both his parents taught him the benefits of hard work. Meanwhile his wife, Doris L.G. Tolentino, and children have helped keep him grounded, he said.

His family members may be the ones keeping him rooted, but Doris L.G.Tolentino said she is overwhelmed by the heights her husband has reached. Already, his 18-year-old stepson, Brandon Moylan, wants to follow in the new judge's footsteps.

"He's good at what he does," Doris Tolentino said.
